Summary Level Reports

The Summary Level reports combine match results, breaks, and valuation statistics for comparative purposes. The four reports are listed below:

- OTC Positions (Summary) - Compares match results for OTC positions by Counterparty using a set of pre-defined tables with statistics for match results, breaks, and valuations
- Collateral Positions (Summary) - Compares match results for OTC positions by Counterparty using a set of pre-defined tables with statistics for match results, breaks, and valuations
- OTC Positions (Counterparty Details)- Provides individual reports of match results in a set of pre-defined tables with statistics for match results, breaks, and valuations for each Counterparty
- Collateral Positions (Counterparty Details)- Provides individual reports of match results in a set of pre-defined tables with statistics for match results, breaks, and valuations for each Counterparty

- OTC Broken Match - Lists Unmatched and Alleged details for the selected As-Of date for up to 10,000 Unmatched and Alleged positions, sorted by largest notional
- Collateral Broken Match - Lists Unmatched and Alleged details for the selected As-Of date for up to 10,000 Unmatched and Alleged positions, sorted by largest notional
- OTC Valuation - Lists valuation details for the selected As-Of date for up to 20,000 positions, sorted by largest NPV difference
- Collateral Valuation - Lists valuation details for the selected As-Of date for up to 10,000 positions, sorted by largest NPV difference
- OTC Breaks - Lists up to 10,000 positions that have Breaks for the selected As-Of date in one or more of the fields in a pre-defined set of priority fields, sorted by largest notional; priority list of fields includes notional, maturity, product and others
- Collateral Breaks - Lists up to 10,000 positions that have Breaks for the selected As-Of date in one or more of the fields in a pre-defined set of priority fields, sorted by largest notional; priority list of fields includes notional, maturity, product and others
